Fund update for quarter ending 31 December 2025. This Fund update was first made publicly available on 13 February 2026.

What is the purpose of this update?

This document tells you how the Betashares Global Sustainability Leaders Fund (NZD Hedged) has performed and what fees were charged. The document will help you to compare the Fund with other funds.

Description of this Fund

The Fund aims to provide an investment return that tracks the performance of the Nasdaq Future Global Sustainability Leaders Currency Hedged NZD Index, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Betashares Global Sustainability Leaders Fund (NZD Hedged)¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

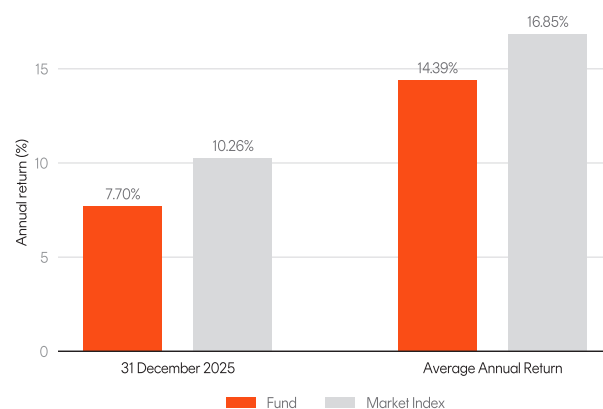

Example of how this applies to an investor²

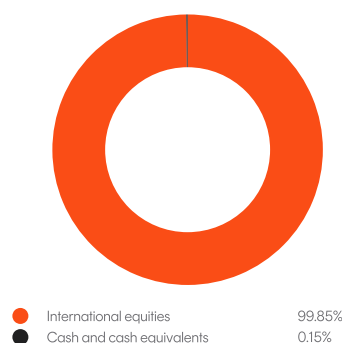
Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$912.51 (that is 9.13% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$769.68 for the year.

¹ Market index returns have been used for the period 1 January 2021 to 20 November 2023 as the Fund was launched on 21 November 2023. The risk indicator reflects the Fund's actual returns for the period 21 November 2023 to 31 December 2025. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
