What is the purpose of this update?

This document tells you how the Betashares Global Quality Leaders Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds.

Description of this Fund

The Fund aims to provide an investment return that tracks the performance of the iSTOXX MUTB Global ex-Australia Quality Leaders 150 Index, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Betashares Global Quality Leaders Fund¹

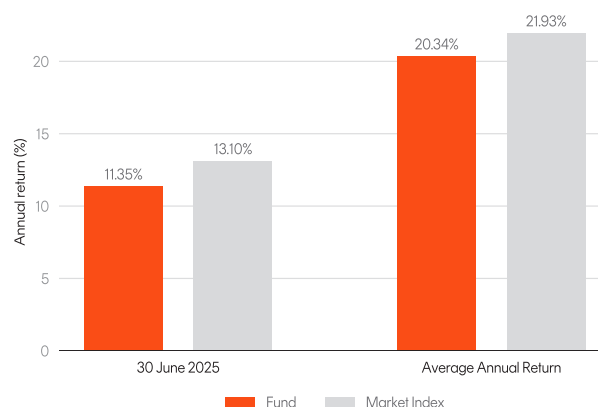

Example of how this applies to an investor

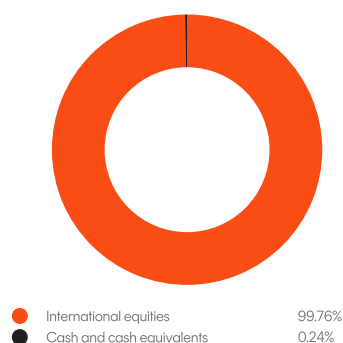
Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$1,285.42 (that is 12.85% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$1,134.77 for the year.

¹ Market index returns have been used for the period 1 July 2020 to 28 May 2023 as the Fund was launched on 29 May 2023. The risk indicator reflects the Fund's actual returns for the period 30 May 2023 to 30 June 2025. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
