## What is the purpose of this update?

This document tells you how the Betashares Global Sustainability Leaders Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds.

The Fund aims to provide an investment return that tracks the performance of the Nasdaq Future Global Sustainability Leaders Index, before taking into account fees and expenses.

# What are the risks of investing?

Risk indicator for the Betashares Global Sustainability Leaders Fund<sup>1</sup>



Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$840.61 (that is 8.41% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$690.96 for the year.
