What is the purpose of this update?

What are the risks of investing?

Risk indicator for the Betashares NZ Sustainability Leaders Fund¹

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor²

Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of -\$17.87 (that is -0.18% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of -\$89.79 for the year.

¹ Market index returns have been used for the period 20 March 2020 (index inception) to 20 November 2024 as the Fund was launched on 21 November 2024. The risk indicator is based on the market index return up until 20 November 2024 and the Fund's actual returns post this date. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
