What is the purpose of this update?


Example of how this applies to an investor²

Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$500.06 (that is 5.00% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$360.04 for the year.

¹ Market index returns have been used to complete the risk indicator, as the Fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund. The risk indicator for the Fund uses 5 years of market index returns. ² As the Fund started on 29 May 2023, this calculation is based on the market index return for the past year.
