What is the purpose of this update?

This document tells you how the Betashares Australian Sustainability Leaders Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds.

Description of this Fund

The Fund aims to provide an investment return that tracks the performance of the Nasdaq Future Australian Sustainability Leaders Index, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Betashares Australian Sustainability Leaders Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor²


Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$1,225.95 (that is 12.26% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$1,097.20 for the year.

¹ Market index returns have been used to complete the risk indicator, as the Fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund. The risk indicator for the Fund uses 5 years of market index returns.

² As the Fund started on 29 May 2023, this calculation is based on the market index return for the past year
