What is the purpose of this update?

This document tells you how the Betashares Global Quality Leaders Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds.

The Fund aims to provide an investment return that tracks the performance of the iSTOXX MUTB Global ex-Australia Quality Leaders Index, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Betashares Global Quality Leaders Fund¹

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor²

Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$2,367.29 (that is 23.67% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$2,233.43 for the year.

¹ Market index returns have been used to complete the risk indicator, as the Fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund. The risk indicator for the Fund uses 5 years of market index returns.

² As the Fund started on 29 May 2023, this calculation is based on the market index return for the past year.
