Fund update for quarter ending 30 September 2023. This Fund update was first made publicly available on 27 October 2023.

What is the purpose of this update?

This document tells you how the Betashares Australian Investment Grade Corporate Bond Fund (NZD Hedged) has performed and what fees were charged. The document will help you to compare the Fund with other funds.

The Fund aims to provide an investment return that aims to track the performance of the Solactive Australian Investment Grade Corporate Bond Select TR NZD Hedged Index, before taking into account fees and expenses.

Example of how this applies to an investor²


Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$640.29 (that is 6.40% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$461.01 for the year.

¹ Market index returns have been used to complete the risk indicator, as the Fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund. The risk indicator for the Fund uses 5 years of market index returns.

² As the Fund started on 29 May 2023, this calculation is based on the market index return for the past year
