Fund update for quarter ending 30 September 2024. This Fund update was first made publicly available on 28 October 2024.

What is the purpose of this update?

This document tells you how the Betashares Australian Investment Grade Corporate Bond Fund (NZD Hedged) has performed and what fees were charged. The document will help you to compare the Fund with other funds.

Description of this Fund

The Fund aims to provide an investment return that tracks the performance of the Solactive Australian Investment Grade Corporate Bond Select TR NZD Hedged Index, before taking into account fees and expenses.

What are the risks of investing?

Risk indicator for the Betashares Australian Investment Grade Corporate Bond Fund (NZD Hedged)¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor²

Matthew had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Matthew received a return after fund charges were deducted of \$1,343.55 (that is 13.44% of his initial \$10,000). Matthew also paid \$0 in other charges. This gives Matthew a total return after tax of \$967.35 for the year.

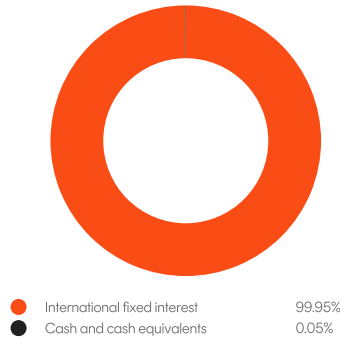
¹ Market index returns have been used for the period 1 October 2019 to 3 July 2023 as the Fund was launched on 4 July 2023. The risk indicator reflects the Fund's actual returns for the period 4 July 2023 to 30 September 2024.
